



**SPECIAL CITY COUNCIL MEETING**  
**November 12<sup>th</sup>, 2013 @ 5:00 P.M. at the Oran White Civic Center**  
**MINUTES**

The City of Tool, City Council meeting was called to order at 5:00 pm. Present were Councilmen Williams, Ellis, Sonka and Daniel. Quorum was established with Mayor Pro-Tem Reeder presiding. Mayor Phillips was out sick.

**ITEM 1:** Consideration and or action to end services with Potter Minton P.C. to be effective immediately. Motion was made by Council Member Daniel, second by Council Member Williams. Motion passed 5-0.

**ITEM 2:** Consideration and or action to sign an agreement with Boyle & Lowry LLP for the retention of services as City Attorney to be effective immediately. Motion was made by Council Member Williams, second by Council Member Ellis. Motion passed 5-0.

**ITEM 3:** Consideration and or action for Kristi Martin to be reassigned from the Tool Police Department's as Dispatch Supervisor; to the Administration Department as City Clerk effective immediately, with no change in her current hourly wage. Motion was made by Council Member Daniel, second by Council Member Ellis. Motion passed 4-1; Council Member Williams opposed.

**ITEM 4:** Consideration and or action to adopt Resolution #2013-02R establishing procedures for road work projects in the city. Motion to adopt was made by Council Member Williams, second by Council Member Daniel. Motion passed 5-0.


**ITEM 5:** Canvass votes November 05, 2013, City of Tool General Election. Mayor Pro-Tem Reeder read the votes: A.J. Phillips for the position of Mayor received 77 votes, Tamra Brickey for the position of Mayor received 86 Votes, Donny Daniel for the position of Council Person received 93 votes and Nathan Reeder for the position of Council Person received 81 votes. The election winner for Mayor is: Tamra Brickey and for Council Person(s) are Donny Daniel and Nathan Reeder. Council Member Ellis made a motion to accept canvass votes for the "November 05, 2013, City of Tool General Election", second by Council Member Williams. Motion passed 5-0.

**ITEM 6:** Install newly elected Council Members and Mayor to assume duty of office effective immediately pursuant to Texas Local Government Code, Section 22.006 and 22.036. Municipal Judge Rhonda Peterson swore Tamra Brickey, Donny Daniel and Nathan Reeder into office.

**ITEM 7:** Consideration and appointment of Mayor Pro-Tem. Motion to appoint Nathan Reeder as Mayor Pro-tem was made by Council Member Williams, second by Council Member Daniel. Motion passed 5-0.

Motion to adjourn was made by Council Member Reeder, second by Council Member Williams. Motion passed 5-0 at 5:10 pm.
