9. Proclaim April as “Child Abuse Awareness” month. Mayor Brickey read the proclamation and proclaimed April as “Child Abuse Awareness” month.


### Old Business

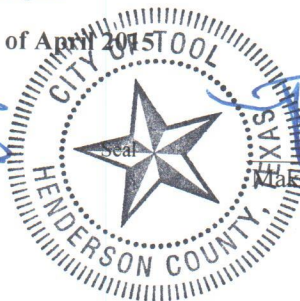


### Closing
